2014 House of Delegates' Report

The House of Delegates (HOD) is a representative body of the AMTA membership that votes on proposed AMTA Position Statements. The Delegates keep the association strategically focused by presenting policy and bylaw changes for the Board of Directors' review. The HOD is structured to represent the opinions of our members and is comprised of elected representatives, Delegates, from each chapter for a term of two years, with a maximum of three consecutive terms. The number of Delegates from each chapter varies by chapter size – New Mexico has two Delegates. Katina Lowe and I represented you this year.

The 2014 House of Delegates was presented with three Position Statements and three Recommendations. A Position Statement is AMTA's position on professional or public policy issues that relate to the mission and goals of the association. An individual member or group of members develops proposed Position Statements to be considered by the HOD. Members have the opportunity to develop Recommendations on AMTA bylaws or policy. This input is one of the many ways AMTA's initiatives are informed directly by our members. AMTA-NM solicited feedback from members by posting the Position Statements and Recommendations on the amta-nm website and on Facebook and in weekly emails to members. Thank you to members who took time to submit feedback and opinions. Please continue to submit your thoughts when we distribute information regarding next years' Position Statements and Recommendations. This is your organization.

Position Statement #1: Massage for Health and Wellness – Motion Passed It is the position of the American Massage Therapy Association (AMTA) that massage therapy can improve health and wellness through its effects on the physical, mental and social well-being of an individual.

Position Statement #2 Proposal on Portability – Not Passed

If passed this motion would have supported portability of credentials which meet the required licensing, certification, or registration of massage therapists across the country. This motion did not pass. Concerns were raised on differing educational requirements from state to state and possibly forcing states to accept licensees with less educational background than minimally required for said state. Additionally, varying of entrance exams for individual state licensure was brought up as concern; however, with the recent change in partnership between NCBTMB (National Certification Board for Therapeutic Massage & Bodywork) and FSMTB (Federation of State Massage Therapy Boards) part of the problem may be resolved for future resubmission and consideration. Position Statement #3 Proposal on Therapeutic Massage for Burn Scars – Not Passed

If passed this motion would have stated that massage therapy can assist in the rehabilitation of burn scars. Debate primarily surrounded the research provided and training. This motion did not pass.

Recommendations

Recommendations passed at the House of Delegates are forwarded to the Board of Directors for review and action.

SC Recommendation to remove the financial responsibility of funding Delegates' attendance to the House of Delegates from the State Chapters' budgets – Motion Passed

Therefore, be it resolved that the House of Delegates recommends to the National Board of Directors that: convention registration, travel expense, 2 nights lodging and 2 days per diem expenses for Delegates to travel to National Convention to attend the HOD meeting should be paid from the National Convention Budget and amend policy as indicated below.

WA Recommendation on Position Statement and the Role of the House of Delegates – Motion Did Not Pass

Therefore: The House of Delegates recommends that the AMTA Board study moving the function of generating and approving Position Statements on the clinical efficacy of massage from the House of Delegates to another group, and that the AMTA Board encourage the House to discuss issues that relate to the actual practice of massage therapy throughout the United States.

CA Recommendation on Chapter Fees – Motion Passed

Therefore, be it resolved that the House of Delegates recommends to the National Board of Directors that *each Chapter* may determine the amount of its Chapter Fee and how to request/acquire said Chapter Fee via

- mandatory assessment
- opt-out contribution
- opt-in contribution or
- o as unnecessary





Susan Salvo Receives AMTA's First Dianne Polseno Award (Portions of this article originally appeared on the AMTA website March 12, 2014)

The American Massage Therapy Association® (AMTA®) congratulates **Susan Salvo** as the first recipient of its <u>Dianne Polseno Lifetime Achievement</u> <u>Award</u>. Susan opened the Louisiana Institute of Massage Therapy (Lake Charles, LA) in 1987 and continues to teach at the school and present massage therapy and ethics continuing education classes throughout the U.S. She has been a practicing massage therapist for 30 years.

"We are delighted to recognize Susan Salvo for her amazing contributions to the massage therapy profession, especially in massage therapy education," says AMTA President Nancy Porambo. "When our board created this award, it was with the idea of recognizing people like Susan. It's very special for her to be our first recipient." In October 2012, AMTA announced the creation of this new award to honor excellence for a person's body of massage therapy work, focused specifically on the area of teaching and education. Because she was an inspiration to educators, students and practitioners for a long time, the award was established in the name of the late Dianne Polseno. It is to be awarded occasionally.

Susan Salvo is well-known for her best-selling massage therapy textbooks, her online courses and instructional videos. Once, when asked about her achievements in massage therapy she said it is about "...helping others achieve their goals, whether living a more pain-free and stress-free life with massage therapy, becoming a massage therapist, or increasing a therapist's knowledge, skills and abilities through post-graduation training."

Susan received the award at the AMTA National Convention on September 18, 2014 in Denver, Colorado and was further recognized at the Teachers' Luncheon during the convention. As mentioned above, Susan will be in Albuquerque, NM at the end of March teaching 11 NCBTMB approved credits in *Research: The New Frontier?* (3 ceu); *Ethics: The Heart of Our Profession* (4 ceu) and *Business and Marketing* (4 ceu) during the 2015 AMTA-NM Annual Conference.




