# Legislative Update

I attended a subcommittee meeting of the Medical, Military, Public and Municipal Affairs Committee at the SC Legislature on May 1, 2013 to voice our support for the amendments to the Massage Practice Act. The legislators had several questions for the LLR Attorney and Carolyn Talley Porter. The subcommittee passed the bill after some discussion with the recommendation for approval along to the entire committee. I had a discussion with the Chair of the Sub-Committee after the meeting and he felt that it should pass through the committee with no problem and be on the Governor's desk for her signature before long.

#### **UPDATE:**

The bill was read for the third time in the SC House and passed by unanimous vote. The bill was then processed into law and presented to the Governor for her signature. The last report I received is that she did sign the law. So I am proud to announce the change in the Massage Therapy Practice Act is now law. I will post the text of the new law on our website as soon as it is published.


