Legislative Review of California's Massage Therapy Act (AB 1147)



2016 Sunset Review

2016: California Legislature will review the current Massage Therapy Act and vote to continue or change the CAMTC (California Massage Therapy Council).

On September 18, 2014, Governor Brown signed Assembly Bill 1147 ([AB 1147](#)) into law. This law revised 2008's **Massage Therapy Act**, and became effective January 1, 2015. It **extended voluntary certification** of massage therapists via the **California Massage Therapy Council** ([CAMTC](#)). The CAMTC was created by the original 2008 Massage Therapy Act, Senate Bill 731 (SB 731).

Major features of the **2014 Massage Therapy Act** included:

- ▶ CAMTC (California Massage Therapy Council) is authorized to continue operating, with a revised Board structure that is reduced in size to 13 members, and mostly composed of non-massage therapy professionals
- ▶ Revised educational criteria and testing requirements for applicants
- ▶ Expanded authority of cities and counties regarding land use authority and local ordinance controls that regulate massage therapy businesses, including sole providers

In 2015, with the return of "land use authority and local ordinance controls" to regulate professional massage, approximately 50 cities in California have enacted moratoriums on approving new massage therapy businesses. A common reason given: this provides the time necessary to review and amend massage ordinances. The actual effect has been to keep massage therapists from practicing.

2016 Sunset Review — California Legislature will assess the 2014 AB 1147 law. One possible outcome of this review: CAMTC is discontinued, and all regulation plus certification of massage therapy business may be returned to California city and county local governments.

Legislative Review of California's Massage Therapy Act (AB 1147)

2016: California Legislature Will Review the Massage Therapy Act, and Vote to Continue, Change, or Retire the State Law Regulating Massage Therapy

The current version of the **Massage Therapy Act (AB 1147)** became effective on January 1, 2015 and will be valid through December 31, 2016. This 2-year bill continued voluntary certification of massage therapists through the **California Massage Therapy Council (CAMTC)**. The California State Legislature must vote to extend the Massage Therapy Act during the 2016 legislative session or it will sunset (expire).

In 2014, the California Legislature conducted a **Sunset Review** of the original 2008 Massage Therapy Law and the CAMTC. This review was to assess the results of the original law, and vote on whether or not to continue the Massage Therapy Act. Such a Sunset Review can yield recommendations to:

- 1) Retain the program or agency as is; or
- 2) Modify the program or agency; or
- 3) Allow the program or agency to terminate, including repeal of relevant laws

2014 Sunset Review Results

CAMTC (California Massage Therapy Council) was authorized to continue operating, but its Board structure was reduced in size to 13 members, and mostly composed of non-massage therapy professionals. Educational criteria and testing requirements for certification applicants was revised.

In 2015, with the return of land use authority and local ordinance controls to regulate professional massage therapy, approximately 50 cities in California have passed moratoriums on opening new massage therapy businesses. The argument by local governments has been that a moratorium provides the time necessary to review and amend massage ordinances. The actual effect has been to keep massage therapists from practicing and blocking thousands of California citizens from having access to massage therapy services.

More cities have established expensive and discriminatory establishment and permit fees, effectively making it too expensive to open or operate a massage business.

In March of 2016, the Massage Therapy Act and the CAMTC will begin its second Sunset Review process, and the California Legislature will assess the effects of Assembly Bill 1147.

What is a Sunset Review?

Whenever the California Legislature creates a law giving authority to a bureau or board to oversee a profession, that law comes up for review every so many years (typically every 5 years, but sometimes less). The Sunset Review Process is an opportunity

for the legislature to evaluate the effectiveness, value and problems of a regulated profession. If the Legislature does not create a new law to continue a profession's credential process, then the law sunsets or ends. The California Massage Therapy

Council (CAMTC) is a not-for-profit public benefit corporation and is subject to this review process (just like the Nursing Board, the Physical Therapy Board, the Acupuncture Board, etc.).

If the legislature chooses not to act on this year's Sunset Bill, then CAMTC will lose its legislative authorization and cease to exist. There would be no more state certification.

All of the privileges that go along with state certification, such as portability and pre-emption from local practitioner credentialing requirements, would end and you would, as was true before 2009, need to get your practitioner permit from each jurisdiction in which you choose to work as a massage therapist.

At this point, there is not a high likelihood of an end to CAMTC and certification, but it is NOT beyond the realm of possibility.

What this year's hearings will most likely be about is the land use authority, which was returned to cities beginning in January of 2015. Under the original Massage Therapy Act (in force from 2009 to 2014), cities were not allowed to create special zoning and fees for massage businesses (meaning offices or spas, actual brick and mortar establishments) that were different from those imposed on other professional businesses (anything from estheticians, physical therapists and acupuncturists to accountants and lawyers).

The benefit of this prohibition is that it kept cities from classifying massage businesses as adult entertainment and regulating us like strip clubs and bars. Cities, however, complained that these restrictions did not allow them to prevent brothels from operating—disguised as massage businesses.

Since AB 1147 (Bonilla) became law, these **land use rights were returned to local control, and the**

result has been the proliferation of punitive and discriminatory local ordinances across California.

What Does It All Mean?

Okay. So you read patiently through all of that. What does it all mean?

It means that this year we go back to Sacramento and ask the state legislators to pass a new version of the Massage Therapy Act that requires regulation of the actual profession of massage, instead of allowing cities and counties to lump therapeutic massage providers in with prostitution, brothels and sex trafficking and undergo punitive establishment permitting process, land use restrictions or additional Livescans to prove that we are not prostitutes.

So What Should You Do?

Maybe these new local ordinances have not affected you, because you do not yet work for yourself. Or you work in a city that hasn't yet amended their local ordinance or placed a moratorium on new massage businesses. But talk to your colleagues, see what it would take to open an office in the city in which you work (or want to work). You could be forced to pay hundreds (or thousands!) of dollars in permitting fees and application costs, just to have a hundred square feet to call your own.

It is time for us to tell State Senators and Assembly Members that they must do something to help massage therapists. It is time for us to act in support of the massage profession.

For 2016 Sunset Review of California Massage Therapy Law: What Should You Do?

Do You Matter?

Unless You Read Past This Headline, You DON'T.



I know. That's mean. Seriously though, if you care about how you are regulated and want to be treated as massage professional instead of a prostitute and a criminal, then read this article and get involved.

2016 will be a big year for massage therapists in California. We have a huge opportunity to finally get the respect our profession deserves. More importantly, we can have that respect translated into a law that treats us as professionals instead of criminals. But for that to happen, rank and file massage therapists—people like you and the other massage therapists that you know—need to stand up and speak up. Complaining isn't enough.

For the state law to change, legislators need to see massage therapists as a profession that shows up to fight for the right to practice without discrimination. A hundred massage professionals speaking up on behalf of the massage profession means makes an impression on lawmakers, much more than seeing the same ten people they saw last year. A thousand massage therapists is a force to be reckoned with.

And the amazing thing is: It is EASY to make your story and your priorities matter.

Here is what you can do now:

Start writing YOUR STORY, especially if you have been negatively impacted by the 2014 Massage Therapy Act revisions. Then when you receive the call to action you can fine-tune it and just hit "SEND"!

2015 Los Angeles Unit Sports
Massage Skills Calibration Class

One of our California Chapter's most exciting current projects is the **AMTA-CA Sports Massage Team**. This worthwhile enterprise has taken several years to gain traction—but over the past year and after a great deal of effort—our Sports Team has actually taken off and is gaining altitude. Therefore, I thought this would be a good time to send out a status report to our AMTA California membership.

Timeline

2013

Lisa Santoro (then Northern Representative prior to being our AMTA-CA President) organized preliminary information to start a statewide Chapter-supported Sports Massage Team. Tom Benson, our California AMTA Mid-State Liaison, began an effort to form a Sports Massage Team based on his prior experience working with the Washington Chapter's highly successful team.

2014

- Tom conducted a Silicon Valley Unit Sports Skills Calibration class.
- Jeannie Martin was appointed Chapter Board Liaison for the Team.
- Since Tom and I began our collaboration, we have marked the following 2015 achievements.

2014–2015

1. We have had four **Sports Massage Skills Calibration Classes** in 2015:
 - 2 in Los Angeles
 - 1 in Orange County
 - 1 in Sacramento

2014: We had one class in Silicon Valley, bringing the total to 5 trainings for a team of just over 100 qualified Event Massage Therapists.

2. Tom and I have put together an **AMTA-CA Sports Massage Team Manual** which explains how we will be operating and what the expectations of a team member will be.
3. On October 9, 2015 Tom and I visited the company where our t-shirts were printed for **World Burn Congress event**, because this vendor maintains the plates for our shirts. There we met with the owner and figured the cost of printing our Sports Massage t-shirts with the AMTA-CA logo. We also decided on magnetic name badges for each therapist,

AMTA California Chapter

We now have a team of just over 100 qualified Sports Event Massage Therapists.

Current Efforts

1. Our California Chapter goal is to hold at least one Calibration Class in each active California AMTA Unit, so we still need to have classes hosted by the:
 - San Diego Unit
 - Redwood Empire Unit
 - East Bay and Golden Gate Units

Members of these Units have expressed avid interest in these classes, so I intend to organize classes in these geographical areas in the next few months.

2. Now that we have this cadre of calibrated and vetted therapists, we are working to schedule in more athletic events. We continue to research events at which our participation would be appropriate.

We will be able to book events in more geographic areas, as soon as we have enough sports massage therapists who can be relied upon to work in each area.

as they work best with sporting events. The California Chapter will have to pay for this initially, but we will be able to recover the cost if we charge every member of the team a \$40 annual fee, as is commonly done in other states.

4. On Saturday and Sunday, October 10th and 11th, our therapists worked at the **MS Coastal Challenge**, a well known cycling event in Southern California.
 - We had 9 therapists working on Saturday, and massaged more than 160 riders.
 - We had 7 therapists working Sunday, and massaged about 90 riders — as less people were riding that day.

The response from the riders was extremely positive: the feedback was that our therapists were much better trained than the therapists at other cycling events. We hope to contract for the Northern California ride next year as well as the Southern California **MS Coastal Challenge** event.

Event Compensation for AMTA-CA Sports Massage Team

We do not expect our massage therapists to volunteer at these events without compensation. Each therapist will be paid accordingly for their work.

Are You Interested in a Sports Massage Career?

Working at athletic events with a trained and vetted team such as the **AMTA-CA Sports Massage Team** is a great opportunity to meet and begin to forge relationships with high level athletes.
