# 2016 AB 2194: Results of Sunset Review for the California Massage Therapy Act

This year, California Legislature reviewed the Massage Therapy Act. This Act was passed in 2008, and amended in 2012 and 2014. The 2014 legislation set 2016 as a "Sunset Review" year to review whether the California Massage Therapy Council (CAMTC), created by the original Massage Therapy Act, would continue to exist and issue statewide massage therapist certifications.

Assembly Bill 2194, which amends California's Massage Therapy Act, was signed by Governor Jerry Brown on September 19, 2016. CAMTC will continue to operate for another four years before the next Sunset Review, through to December, 2020.

# The 2016 Assembly Bill 2194 goes into effect on January 1, 2017.

This bill amends the state regulations for our profession.

- Most importantly, it extends voluntary certification through the CAMTC for four years (through December 31, 2020). This creates stability for us as certified massage professionals and makes it easier for local governments to create better local ordinances.
- It requires that local governments "impose and enforce only reasonable and necessary fees and regulations on massage businesses and massage establishments." This amendment creates a foundation for us, as professional massage therapists, to work with local governments in advocating for better regulation in our own cities.
- It prevents local ordinances from requiring

showers; a seemingly small thing, unless you are trying to find affordable office space on a massage therapist's budget.

- It clarifies language making it illegal for local jurisdictions to require, and charge for, redundant background checks on CAMTC certificate holders when they apply to open a massage business.
- It includes intent language suggesting that local governments give consideration to using revocable establishment registrations as a regulatory tool. This strategy gives local governments a quicker and more cost-effective means of closing brothels posing as massage businesses.

While these amendments do not solve all of the problems we have with discriminatory local massage ordinances that exist across the state, they are solid improvements to the Massage Therapy Act.

#### Tony Siacotos Report, Fall 2016

I would like to offer a warm thank you to the hundreds of you who took part in our advocacy efforts this last year. Your testimony at hearings in Sacramento, visits with your

state legislators, and emails in support of Assembly Bill 2194 (2016 Massage Therapy Sunset Bill) made these changes happen.

Photos to the right show some of the California massage therapists and AMTA government relations activists that attended 2016 massage therapy legislative meetings in Sacramento.

So... where do we go from here?

We had, on balance, a moderately successful 2016 year in Sacramento. We succeeded in changing the narrative from "massage establishments are really brothels" to "this is the burden that regulating massage as adult entertainment has on the practice of massage." Still, the power of local governments is strong in Sacramento, and we did not get an amended Massage Therapy Act that decisively puts a stop to that.

But we did get you a bit of leverage. And that's what I want to talk to you about now. In 2014, cities had land use controls returned to them. Historically, local governments commonly regulated massage establishments as adult entertainment businesses instead of healing arts practices.

Most of the cities that re-wrote their massage ordinances after 2014 used their land use controls to reinstate the terms of these adult entertainment ordinances. These restrictive and punitive requirements include:

- Requiring time-consuming and expensive conditional use permitting of massage establishments.
- Expensive fees to open and/or renew an establishment permit.

- Zoning restrictions that prevent a massage establishment from locating where other healing arts businesses are typically located.
- Zoning restrictions that prevent a massage therapy establishment from locating within 1,000 feet of another massage therapy establishment, or from a church, school, or public building or park.

It is important to note that these requirements are not imposed on other healing arts businesses.

In 2016, the Massage Therapy Act was amended to require that local governments "impose and enforce only reasonable and necessary fees and regulations on massage businesses and massage establishments." So now we need to begin having conversations with cities that have written discriminatory massage ordinances, and those that are about to. That is where we go from here.

Mark Dixon gratefully received this position, and said: "It has been an honor to be appointed to serve on the CAMTC Board, and I am grateful for the opportunity to support its mission of public protection." Representing the AMTA California Chapter at the meeting were President Jeannie Martin, Secretary Nathan O'Hara, and Northern Representative Patricia Rusert Gillette.

Mark W. Dixon entered the massage profession in 1988, and has volunteered in service to his colleagues, who have become valued friends, teachers, and mentors ever since. He has volunteered continuously for the AMTA, The Massage Therapy Foundation, the National Certification Board for Therapeutic Massage and Bodywork for the U.S. Olympic Committee since 1988.



The California Massage Therapy Council ("CAMTC") was created by the California Legislature through the enactment of Senate Bill 731 and re-authorized by Assembly Bill 1147 and again in 2016 by Assembly Bill 2194. CAMTC is a private nonprofit public benefit corporation. CAMTC is required by California Business and Professions Code to:

- 1. Create and implement a voluntary certification program for the massage therapy profession (CMTs).
- 2. Ensure that certified massage professionals have completed sufficient training at approved schools.
- 3. Approve massage schools. As of July 1, 2016, CAMTC only accepts education from massage school programs that have been CAMTC approved.

#### **IRONMAN®** Triathlon History

The IRONMAN<sup>®</sup> triathlon events started in 1978, and grew from one Hawaii site to current annual events in North America, South America, Europe, and Africa.

During an awards banquet for the Waikiki Swim Club, John Collins, a Naval Officer stationed in Hawaii, and his wife Judy, began playing with the idea of combining the three toughest endurance races on the island into one competition. They decided to issue a challenge to see who the toughest athletes were: swimmers, bikers, or runners. On February 18, 1978, 15 competitors, including Collins, came to the shores of Waikiki to take on the first IRONMAN<sup>®</sup> challenge.

The slogan for this IRONMAN<sup>®</sup> event became:

#### "Swim 2.4 Miles. Bike 112 miles. Run 26.2. Brag for the rest of your life."

#### IRONMAN<sup>®</sup> Triathlon Annual Events Oceanside, California

In the Oceanside annual events, Brian Arakaki leads a team of students from Fullerton College Massage Therapy Program and other volunteers at this classic triathlon race each year. For over 12 years, he has also has been leading the Acute Cramp Care stations in Kona for the annual IRONMAN<sup>®</sup> World Championship. These cramp care stations were established 28 years ago by Dr. Myk Hungerford, the Mother of Sports Massage.

#### SUPERFROG® Triathlon Events

Prior to partnering with the IRONMAN<sup>®</sup> annual race events in 2014, the SUPERFROG<sup>®</sup> Triathlon was founded in 1979. This challenging course with the longest running half-distance race was designed by a group of Navy Seals stationed at the US Navy Seals center in Coronado to both prepare them for the IRONMAN<sup>®</sup> World Championship in Kailua-Kona, Hawaii, and to enhance their training. This triathlon, with 85% military services participants, became part of the annual IRONMAN<sup>®</sup> events in 2015.

This promotion came to me a few years ago by accident. It was all because the parents in my kid's classes started talking about buying the teacher a holiday gift from the class. I realized it was a perfect opportunity to let the parents know about my private practice and give them a way to get extra value on purchasing a massage gift from ME rather than from some unknown spa.

#### This 3-step promotion works really well to:

- (a) generate exposure for your business
- (b) make some sales to bring in revenue
- (c) get new clients
- (d) provide huge value to the group so they literally get more bang for their buck!

This **Group-Leader Promotion** can work well for your husband's company boss, the church clergy, your karate club... anywhere the members in that group get together to buy a gift for their leader.

#### Group Leader or School Teacher Holiday Gift Certificate Idea, Continued

#### How It Works:

- #1. Usually there is a person in the group who starts an email or conversation to the group saying they would like to get the teacher (or group leader) a gift. Massage comes up as an option quite often. (Aren't we lucky!) If no one starts the conversation, feel free to start it yourself.
- #2. Send the group a quick email letting them know you'd be happy to offer them a big savings on your service for the teacher's gift.
  (Or sell it at your standard rate but include an extra gift of additional time, or added service add-on.)

**Sample:** "Some of you might be considering joining together to get Mr. Castillo a gift for the Holidays. I would be happy to offer a gift certificate for services at my clinic. The group can all pitch in for an hour massage and I will provide an extra 30-minutes of massage to the gift at no additional fee!

(This will give Mr. Castillo a 90-minute massage therapy session for the price of an hour!)"

#3. Provide the same special to the rest of the group or class for their own shopping needs.

**Sample:** "In addition to the class gift, I am happy to extend this same offer to you if you would like to purchase massage gift certificates for your friends and family. (90-minute massage therapy sessions for the price of an hour!)"

It is really that simple!

You've now got a novel idea to generate extra sales over the holidays while providing extra value to the people you know. If you would like even more help with the wording and tone of the offer to the group, you can see the EXACT email that I sent to my kid's class to offer them the opportunity to buy a gift certificate. You can use my letter as a sample to model for your own.
